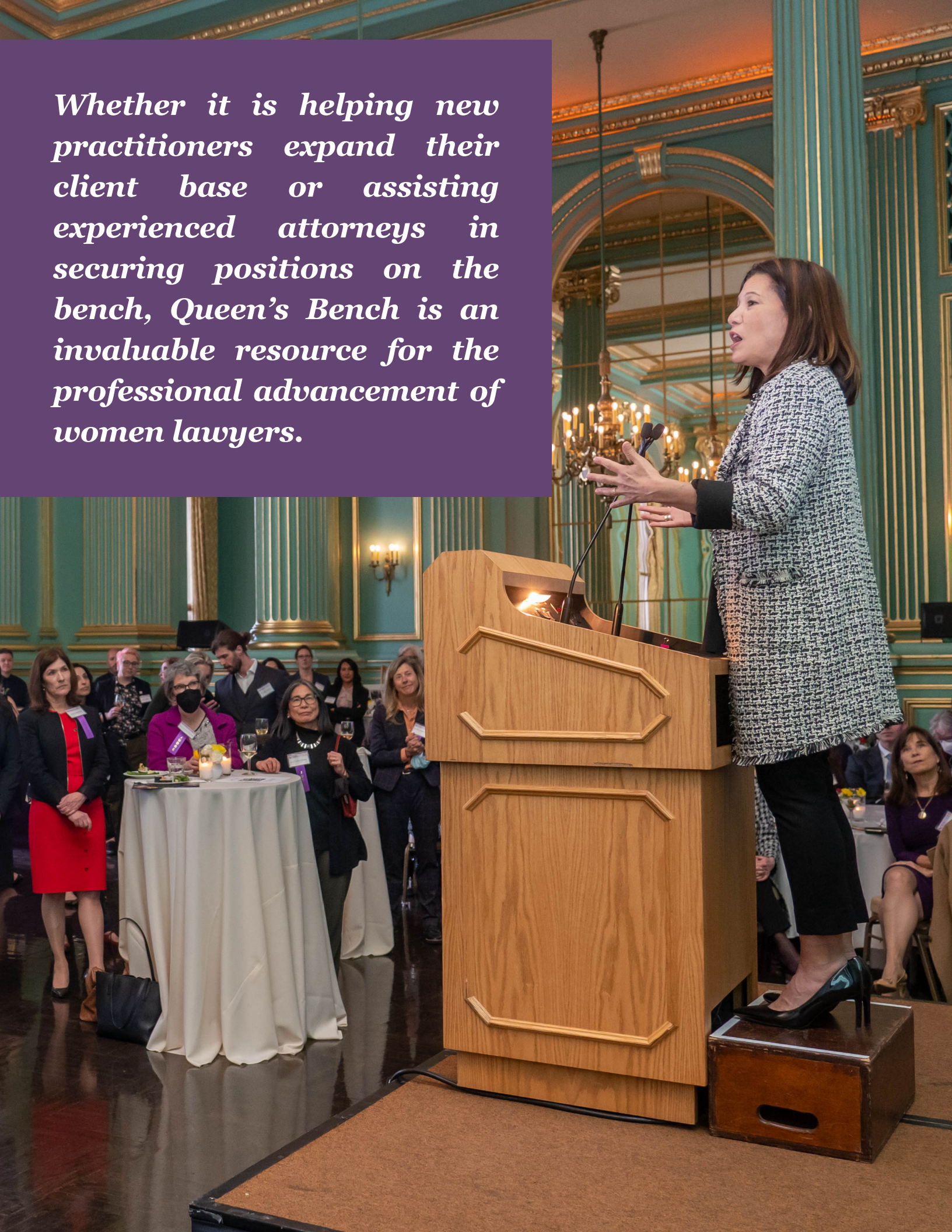
For more than a century, Queen's Bench has promoted the inclusion of women in the legal profession. Queen's Bench Bar Association of the San Francisco Bay Area was formed in 1921 by a group of women lawyers frustrated by the resistance of male lawyers to their participation in the local bar association.

Since its founding, Queen's Bench has helped numerous Bay Area women attorneys achieve in the profession and has been a force to build a more diverse and inclusive bench.

Queen's Bench organization includes sixteen committees that organize and host programs to eliminate gender bias in the legal community, support women lawyers in assuming positions of leadership, advocate for women's rights, and encourage adoption of legislative and judicial reforms. The committees also sponsor periodic employment surveys, work to increase the representation of women on the bench, and write amicus briefs on major issues affecting women. Queen's Bench plans ongoing events and meetings geared towards meeting the professional needs of women lawyers, judges, and law students. Queen's Bench also supports numerous community projects, and sponsorship of scholarships for promising law students at University of California College of the Law, San Francisco, and University of San Francisco law schools.



Whether it is helping new practitioners expand their client base or assisting experienced attorneys in securing positions on the bench, Queen's Bench is an invaluable resource for the professional advancement of women lawyers.





Annual Induction Ceremony

Generally held in the spring of the year, this is an annual champagne reception held in honor of our incoming Board of Directors and new admittees to the State Bar of California. Numerous members of the Northern California judiciary attend this event. The 2024 Induction Ceremony will be held in late February.

Past Presidents' Dinner

Generally held in the fall of the year, the Past Presidents' Dinner celebrates our bar association's rich history and traditions while honoring our Past Presidents. As one of the oldest women's bar association in the United States, During this dinner, our former leadership and experienced members impart wisdom and guidance to our membership. This year, the Past President's Dinner will be held in late April 2024.

In addition to reflecting on our history and leadership, awards are presented to current members. Awards presented include the Lifetime Achievement or Merit Award to a Queen's Bench member whose work in furthering the interests of women is above and beyond the expected and ordinary; the Service Award to a member demonstrating exemplary service to the Bay Area community; and the Rookie Award to a member within their first year of membership who demonstrates promising talent and dedication to the bar association.

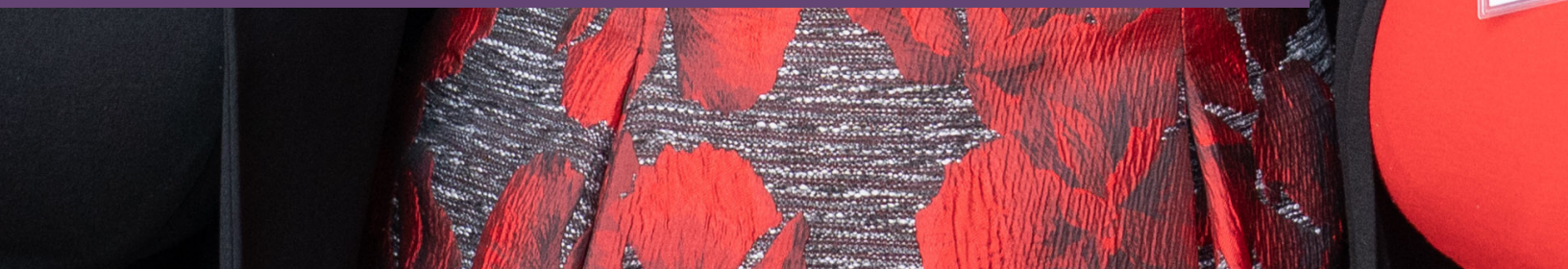
Counsel Table Sponsorship (\$2,000)

LEAADD Annual Reception

In the early 1930's, members of the Women's Physicians of San Francisco invited women lawyers from Queen's Bench to a luncheon to discuss issues common to both professions. This gathering became an annual tradition and is now expanded to include engineers, architects, accountants, dentists and women from all other professions. Throughout the years, the LEAADD annual meetings featured outstanding speakers addressing topics of current interest to women. Notable speakers include former Chief Justice of the California Supreme Court, Rose Bird; author, Jessica Mitford; former State Treasurer, Kathleen Brown; former National Organization for Women President, Ginny Foat; Chez Panisse; and Alice Waters. Last year's keynote speaker was author, television and radio journalist Belva Davis.

Annual Judges' Dinner

Each year, Queen's Bench hosts this evening event to provide a forum for the outstanding women of our time to address our membership and the local judiciary. Various members of the Bay Area legal community, California Supreme Court and courts of appeal, trial court judges, and political officials at the state and local level gather at our largest event of the year. The event is hallmarked by a keynote speaker, always a woman of substance and stature, who speaks on contemporary issues of interest and importance to women in general and women attorneys in particular.

Previous speakers for this event include California Supreme Court Justices Joyce Kennard (a lifetime Queen's Bench member) and Kathryn Werdegar; U.S. Senators Dianne Feinstein and Barbara Boxer; former Planned Parenthood president, Faye Wattleton; author Susan Faludi; attorney Sarah Weddington, who argued *Roe v. Wade* before the United States Supreme Court; Roberta Achtenberg, Commissioner of the U.S. Commission on Civil Rights; and renowned feminist, teacher, attorney and activist Catharine MacKinnon. Last year's keynote speaker was the Honorable Lucy Koh of the United States Court of Appeals for the Ninth Circuit, pictured on the previous page with 2023 President Kimiko Akiya.

Website Project

Beginning in 2023, Queen's Bench initiated its inaugural website modernization project to revise the bar association's website and contents. The project was prompted by Queen's Bench's recent celebration of our centennial anniversary -- which reflected upon our members' accomplishments in the past century and future success over the next century. Scholarships

Examples of our ongoing scholarship programs are below.

Mildred W. Levin Scholarship

This scholarship was established in honor of the University of California College of the Law, San Francisco (formerly Hastings) alumna. The scholarship is awarded to second or third year students at UC Law SF with financial need who exemplify the ideals represented by Mildred Levin; intellect, determination, compassion and integrity. Recipients are selected by the Queen's Bench Scholarship Committee.



Agnes O'Brien Smith Scholarship

This scholarship was established by Dr. Philip Smith in honor of his mother. The Agnes O'Brien Scholarship is awarded to second and third-year law students at the University of San Francisco School of Law based on financial need, academic scholarship, leadership, and community service. Agnes O'Brien Smith, Class of 1941, was an admired jurist and lawyer and the first woman named to the American Board of Trial Advocates. O'Brien Smith also served as president of the Queen's Bench, which administers the scholarship and selects the scholarship award recipients.

Marjorie B. Anderson Scholarship
