#### PRESIDENT'S MESSAGE

#### Our 91st Year

Founded 1921

Queen's Bench begins its 91st year in 2012. While it's impressive to reflect on the tremendous



obstacles female attorneys have overcome during this time, many endure, such as lack of pay parity and the vastly greater number of men in leadership roles. Moreover, new challenges worthy of our attention have come to the fore. One such issue, relevant to Queen's Bench's goals of "promoting and maintaining the sound administration of justice" and "furthering equal opportunity for all women," is the crisis in court funding.

As you are probably aware, like other critical services for California residents and businesses, California courts have suffered major budget cuts since 2008. Over the past four fiscal years, the judicial branch has experienced a cumulative ongoing reduction of \$653 million (\$606 million in reductions to trial courts and \$47 million in reductions to the Supreme Court, Courts of Appeal, and the Judicial Council/Administrative Office of the Courts). These cuts could be exacerbated if a set of current fees that accounts for \$70 million of the branch's budget sunsets in fiscal year 2012-13. In the past, the Judicial Council has been able to mitigate some of the reductions to the trial courts through fund redirections and by creating and raising fines and fees.

### San Francisco Law Library Closes Market Street Branch

The San Francisco Law Library announced on February 6 that its branch library in the Monadnock Building at 685 Market Street will close on March 5th. Comprehensive library and reference services will continue to be provided at the main Law Library located in the Veteran's War Memorial Building near City Hall. A major decline in library funding from court filing fees, greatly increased rental rates, and an unrelenting escalation in the cost of legal materials led to the move.

"We deeply regret that the Financial District branch must close, but the lease for the space is up this spring,

and the Law Library simply cannot afford current market rental rates, while income continues to decline and legal information costs soar," said Law Librarian Marcia Bell, who has headed up the Law Library for the past 21 years. "Although it is unusual for a city this small to have two law library branches, the Financial District branch has been

in existence for more than 60 years and we held on to that location as long as we possibly could."

"The Law Library is financed by court filing fees, which have declined 14% since last year and 20% since 2009. Our commitment to serving the public hasn't changed, but closing the branch will allow us to conserve resources to provide comprehensive services at the main library," Bell concluded.

Hours at the main Law Library at 401 Van Ness Avenue will be extended to provide the same hours as currently available at the branch: Beginning March 5th, the Law Library will be open from 8:30 a.m. to 6:00 p.m. Monday – Thursday, 8:30 a.m. to 5:00 p.m. on Friday, and from 10:00 a.m. to 4 p.m. on Saturday. Additional computer terminals dedicated to legal research will be added in the main library, along with new work tables to accommodate former users of the Market Street branch. Some library materials will be moved from the branch to the main Law Library, but duplicate materials will be eliminated.

The branch closing comes at a time of change for the main Law Library as well. The Veteran's War MemorialBuilding, where the Law Library is currently housed, will close for refurbishing in May 2013 and the Law Library is currently working with an architectural planning firm to develop options for new space.

Until San Francisco City Hall closed in 1995 as a result of damage caused by the 1989 Loma Prieta earthquake, the Law Library shared the 4th floor with the Superior Courts and was regarded as one of the premier county law libraries in the state. The Law Library moved to the

Veteran's War Memorial Building in 1995 and 17 years later is still housed in the same "temporary" inadequate space.

"The Law Library in the Financial District has had a very long and successful run, and I am one of many who have gratefully used it for research for my law practice; but it's not possible to support a branch library in this economic climate," said Kurt Melchior, President of the San Francisco Law Library Board of Trustees. "The Board of Trustees will now focus its full attention on working with the Law Library staff and the City of San Francisco to find

a permanent solution to the Main Library's ongoing space crisis. It's essential that we locate and secure a commitment from the City for an adequate and well located new site for the Main Library by May 2012."

Most of the Law Library's funding is provided from court filing fees through California Business & Professions Code 6321. The City and

County of San Francisco is mandated by state law and the San Francisco Charter to provide library quarters and utilities at the main Law Library, funding for three positions and a nominal sum for supplies. The Law Library is not funded by state or local tax dollars.

"We hope and expect that the San Francisco legal and business communities, as well as the public at large, will support the Board of Trustees' efforts to secure a proper permanent home for a free, full-service Law Library, which is vital to preserving the legal rights of all our citizens," said Melchior.

It is the mission of the San Francisco Law Library to provide the judiciary, the public, the bar, and government officials with free access and use of legal reference materials in order that they may conduct their legal affairs and preserve their legal rights. Written and directed by Jennifer Siebel Newsom, Miss Representation exposes how mainstream media contribute to the under-representation of women in positions of power and influence in America. The film challenges the media's limited and often disparaging portrayals of women and girls, which make it difficult for women to achieve leadership positions and for the average woman to feel powerful herself.

Miss Representation includes stories from teenage girls and provocative interviews with politicians, journalists, entertainers, activists and academics like Condoleezza Rice, Lisa Ling, Nancy Pelosi, Katie Couric, Rachel Maddow, Rosario Dawson, Jackson Katz, Jean Kilbourne, and Gloria Steinem. The film offers startling facts and statistics that will leave audiences shaken and armed with a new perspective.

"We are thrilled to have so many outreach opportunities for Miss Representation. This film was made to be a change agent in our culture, to inspire both women and men to recognize women's collective voice, leadership capacity and equal rights," says Newsom.

In a society where media is the most persuasive force shaping cultural norms, the collective message that our young women and men overwhelmingly receive is that a woman's value and power lie in her youth, beauty, and sexuality--and not in her capacity as a leader. While women have made strides in leadership over the past few decades, the U.S. is 90th in the world in terms of women in national legislatures, women hold only 3 % of clout positions in mainstream media, and 65% of women and

girls have an eating disorder.

Miss Representation was selected from the Sundance line-up to be part of the OWN Documentary Film Club. "Through personal stories and provocative interviews, Jennifer crystalizes the relevance of the media and its portrayal of women in today's society," said Lisa Erspamer, Chief Creative Officer for OWN. In addition, ro\*co films is currently distributing Miss Representation to educational institutions and libraries for classroom use and university screenings.

However, these re-directions were one-time solutions and are increasingly unavailable. These reductions are now negatively affecting the ability of Californians to seek resolution within their legal system.

While these cuts are of interest to all attorneys, they may be of particular concern to Queen's Bench members because they have a disproportionate impact on women and children. For example, Bay Area Legal Aid, the largest provider of free legal services in Northern California, issued a report in October 2011 describing how Bay Area courts lack the resources to protect domestic violence victims and children. In fact, almost 70% of legal aid providers have reported negative effects on their clients from court funding cuts. The impact of these cuts is illustrated by stories of women forced to sleep in their cars because they were unable to get immediate restraining orders in the face of domestic violence and child custody orders delayed due to the lack of court resources.

On January 11, the State Bar Association, in partnership with the Open Courts Coalition held a meeting with bar association leaders to discuss the funding crisis. Speakers at the meeting explained that the courts are vulnerable to budget cuts, in part, because they do not have a constitutionally mandated baseline level of funding and because they lack a constituency. To give a voice to the courts, the Open Court Coalition/State Bar Association partnership is seeking the support from lawyers from both sides of the bar, bar associations and law firms to approach Governor Brown and the Legislature as a unified group to seek partial restoration of court funds cut from the budget in from the last several years and ensure that no further cuts are made in this year's budget. The hope is that if the Legislature sees a very diverse group of bar leaders come forward with the same
