# Past Presidents' Dinner, 2013

Queen's Bench held its Annual Past Presidents' Dinner at the Concordia Argonaut on November 19, 2013. It was a successful event by any measure. There were 22 Past Presidents in attendance, all wearing stylish hats, a long held tradition for this event. The Honorable Justice Katharine Werdegar was the worthy recipient of the 2013 Lifetime Achievement Award. Our Past Presidents were pleasantly surprised to see Justice Werdegar sporting her own hat when she went to the podium to accept her award, expressing delight in this tradition. Justice Werdegar was appointed to the Court of Appeal in 1991, and the California Supreme Court in 1994, among many other achievements. Justice Werdegar has been a great supporter of Queen's Bench, most notably by presiding over our annual Induction Ceremony, a service she has graciously provided for many years.

The evening's raffle, silent auction, and live action raised over \$6,000 for the Queen's Bench Foundation. The Foundation serves many Queen's Bench programs including the award winning Juvenile Hall Project and Color of Justice Programs. The Juvenile Hall Project has been an important recipient of Foundation funds since it was founded. Through the Project, Queen's Bench attorneys visit with girls at the San Francisco Juvenile Detention Center

and provide opportunities for healthy creative expression and positive interaction with strong female role models. The Honorable Ina Levin Gyemant, Queen's Bench President 1979, and Kelly Robbins, Queen's Bench President 2008, with some spirited assistance from the Honorable Angela Bradstreet, Queen's Bench President 1989, presided over the live auction. Judge Bradstreet had coordinated two original drawings by Senator Dianne Feinstein. The competitive bidding over the second drawing resulted in two bidders deciding to join together and timeshare their drawing. The next day, Judge Bradstreet procured another drawing from Senator Feinstein so each co-bidder could enjoy her own drawing. A happy ending for all, and the family law attorneys in our group are now breathing a sigh of relief that there will be no custody battles over the drawing!



# Affiliate Re-Certification: Why Should Queen's Bench Members Join CWL?

Queen's Bench is currently going through the process of re-certifying as an affiliate organization of California Women Lawyers (CWL). What does this mean for you, as a member of Queen's Bench?

To be a voting affiliate and have an Affiliate Governor on CWL's Board of Governors, Queen's Bench needs to have 20% concurrent membership with CWL (or 100 CWL members, whichever is less). Affiliates are absolutely essential, not just to CWL's strength and growth, but to the strength and growth of a statewide network of women lawyers. Sacramento and Washington listen to this network.

California Women Lawyers is the only statewide organization with the mission of advancing women in the legal profession and in society. Since its formation, CWL has exercised a leadership role in promoting the advancement of women and eliminating bias in our profession and throughout society. In recent years, CWL has organized face-to-face meetings with leaders of women's bar associations across the state and with the Judicial Appointments Secretaries in administrations across the political spectrum; spear-headed legislation focused on issues vital to women and children; and initiated a statewide mentoring network enabling women lawyers from throughout California to connect with one another and gain insights into career advancement, balancing work and private life, and resolving other challenges of practice in today's world. In 2012, CWL launched its In-House Counsel Network so that CWL and women in-house counsel from across the state and from across industries can partner to work on common issues, such as breaking the glass ceiling and promoting women in the law, gender pay equity, and bringing diversity to corporate legal departments and law firms. CWL additionally writes or joins amicus briefs in cases that affect women's rights, at both the state and national level, and it hosts an annual conference to present cutting edge programs specifically directed to the advancement of women in the law.

CWL's statewide legislative work distinguishes it from other women's bar associations because it provides a cohesive, singular statewide voice supporting legislation that seeks

to advance women in the law and society. CWL's office is located directly across from the State Capitol building in Sacramento, where, for many years, it has had an active and visible presence. CWL is known and respected, and is often asked its opinion, both by legislators and by the Governor's staff. Together, CWL and its affiliates are able to make our voices heard in a way that would be impossible for a single local bar association.

With the help of its affiliates, CWL will continue its vital and effective work to promote diversity on the bench, through a combination of judicial evaluations, its signature award-winning "So, You Want To Be A Judge?"™ seminars, and communications with the Governor's Judicial Appointments Secretary and United States Senators. CWL is also continuing to expand its pipeline programs to help girls think about law as a career and women lawyers plan their careers to maximize the possibility of being appointed to the judiciary.

CWL additionally serves as a liaison to national organizations, such as the National Association of Women Judges, and is a member of the National Conference of Women's Bar Associations. As a strategic ally with the National Association of Women Lawyers, CWL shares ideas on national and statewide platforms and is currently working on bringing some of NAWL's programs to California. Through activities with these organizations, CWL is able to have a voice on a national, and sometimes international, level.

Being a member of both Queen's Bench and CWL is not duplicative—the organizations work in a complementary way. Queen's Bench provides tremendous support for women locally, and CWL is an effective advocate for women lawyers (and women generally) throughout the state and nationally. By being a member of Queen's Bench and CWL, and by facilitating Queen's Bench's status as a CWL affiliate, you can ensure that women's voices are heard—both near and far.

## Eyes on the Prize: Equity in the Legal Profession

Diversity is a topic we often broach in the legal community. Companies and law firms alike have realized the need for diversity among the ranks of their organizations. We are all aware that diversity brings about unique perspectives to problem-solving and assists in building relationships as we embrace a global economy.

As a Queen's Bench member, you understand the importance of diversity and particularly the role it plays in our legal community. But, in addition to being an example of what women can achieve, what have we done? How have we supported more forms of diversity in our law firms, companies, or government offices?

Queen's Bench has recognized that there is always more to be done. Though the number of women in legal careers is growing, there are still great strides to be made in advancing women in minority communities, whether based on ethnicity, socio-economic status, sexual orientation, age or physical ability. Embracing the practice of creating diverse and inclusive workplaces is about recognizing and accepting who we are, and giving due recognition and value to those around us. It's about understanding how our identities relate to and affect others. And, most importantly, it's about opening doors for others who are not afforded the same privileges each of us may enjoy.

Let's be clear. Each of us is privileged in some way. So, there is no reason to be ashamed of your privilege. Rather than feeling ashamed, it is useful to discuss privilege and question assumptions that do not hold true for other women. From there, we can build strategies to invite a wider range of experiences into our promotion of women in the law. This is how we will build a diverse and more inclusive legal community.
